The EBR School Board has proposed turning the site into an E-Sports complex where competitive video gaming and robotics tournaments will take place.

Violators will be ticketed and possibly towed.

### SFCA and Crime District Roles Compared

#### SFCA HOA (Established 1956)

- Funded by \$50 HOA dues paid to SFCA and renewed each January.
- Currently, less than 500 residents have paid dues. Please support your neighborhood.
- Board members are volunteers who give per 
   sonal time for Sherwood Forest.
- HOA must exist to have a Crime District.
- Enforces Deed Restrictions, can file suit and funds any legal action.
- Approves or denies requests for home additions and improvements through the Architectural Control Committee to ensure neighborhood harmony.
- Meets with the Mayor, Metro Council and Planning Commission.
- Operates the Eye Watch Block Captains.

### CRIME DISTRICT (Established 2013):

- Funded by tax assessment paid to the sheriff's office.
- Cannot exist without an active HOA.
- Board members are volunteers.
- Cannot enforce deed restrictions and cannot pay court costs.
- Purchases and operates neighborhood cameras.
- Employs and coordinates officers for neighbor-
- hood patrols that enforce the city ordinances. Patrols are not 24/7
- For police assistance call 225-389-2000 or 911, if our patrols are on duty, they will answer the call.
- Maintains flower beds and entrance signs.

## **Do I Need SFCA Approval, a Permit, or Both? (FAQ)**

- Does Sherwood Forest have deed restrictions? YES, see www.sfcabr.org to find the deed restrictions that apply to your filing.
- Can I build a workshop, shed, greenhouse, mother-in-law suite, pour a new driveway? Submit your plans to the SFCA Architectural Control Committee (email jrjhgray@cox.net) for approval. This committee reviews the plans to ensure that deed restrictions are followed and the structure is in harmony with yours and neighboring houses. City permits may also be necessary.
- Can I place a shed at the end of my driveway. No, contact the Architectural Control Committee for proper placement.
- Do I need a permit to build a carport or other structure? YES, in most cases. In addition, you need SCFA approval.
- Can I run a car repair business or other business at my house? NO, this is prohibited in an A-1 zone. Please report to 311.
- Can I park my car on the street overnight? Parked cars on the street impede passage of emergency vehicles and is therefore discouraged. Parking in the yard is illegal and the vehicle will be ticketed.

### New Residential Self-Service, Non-Perishable Solid Waste **Collection Facility**

The City Parish has announced the opening of the new Residential Self-Service Non-Perishable Solid Waste Collection Facility located at 7900 Starwood Court, in the Gardere area.

### Accepted Materials (variety of non-perishable residential waste), including:

Household bulky waste (like furniture, bicycles, and toys) Scrap metal Drained automobile parts Tree trimmings and yard waste (with restrictions) Homeowner-generated construction debris (limited quantities) Materials that are not accepted at the facility include: Perishable household garbage Commercial/industrial solid waste White goods (including appliances like refrigerators, freezers, washing machines, water heaters, or air conditioners)

Electronic waste (including TV's, stereos, and game consoles) Medical waste Tires and hazardous materials

### Spring/Summer Gardening & Landscaping

Keeping a lush, green lawn in South Louisiana is a yearround commitment. With high humidity, heavy rainfall, scorching summers, and occasional droughts, maintaining a healthy lawn in Baton Rouge requires a strategic approach. To help homeowners manage their lawn throughout the spring and summer, we've got lawn care tips that ensures your yard stays green, weed-free, and resilient in Louisiana's unique climate.



- Begin regular mowing Keep grass at 3-4 inches to shade out weeds.
- Apply pre-emergent herbicides Prevent broadleaf weeds and crabgrass from sprouting.
- Fertilization Apply a balanced fertilizer to promote healthy green growth.
- Aeration (if needed) Helps break up compacted soil and improves water absorption.
- Check irrigation system and water (mornings and evenings) when necessary.




### New Speed Limit Radar Signs

At the beginning of 2025, your SFCA board contacted EBR Director of Transportation Fred Raiford regarding the excessive speeding and accidents on Sherwood Forest Blvd. He installed temporary radar speed limit signs which gathered data showing the signs were effective by slowing traffic, resulting in fewer accidents.

In March, permanent signs were installed on Sherwood Forest Blvd at Mollylea Drive. A big "Thank You" to Fred and his staff for hearing our concerns and making Sherwood Forest a safer place to live.

## **MOVEBR Program**

As part of the MOVEBR Program, the contract to replace the South Flannery Road bridge should be awarded by July of 2025. Construction should be complete within 10 months.

The Sherwood Forest Blvd Multi-Use Path Project between Old Hammond Highway and I-12 is underway and should be completed by May 2025.

The contract to widen Old Hammond Highway is in the bid stage. Construction will continue through 2026.

Entergy is replacing the natural gas lines in the rights of way in the southeast quadrant of Sherwood Forest. This work should be complete by May 2025.





### Louisiana Fire Ants

Anyone who has spent time walking barefoot on south Louisiana lawns has eventually been bitten by fire ants. Needless to say it's a painful experience and could even be hazardous for those developing anaphylaxis following multiple fire ant stings.

#### Signs of Fire Ant Allergic Reaction (Anaphylaxis)

Difficulty Breathing,Swelling of Tongue and ThroatRapid heartbeatDizzinessLoss of ConscienceSeek Immediate Emergency Medical Attention!

#### Treating Fire Ant Mounds

#### Use the two-step method: Baiting and Mound Drenching

- 1. Use bait to kill the queen and other worker ants deep in the colony.
- 2. Use insecticide for targeted treatments on the mound.
- 3. Douse the fire ant mound with boiling water.
- 4. Drench the ant hill with a pesticide.
- 5. Bait worker ants in order to kill the fire ant queen.
- 6. Spread a broadcast insecticide treatment.
- 7. If all else fails, call in a professional exterminator.
